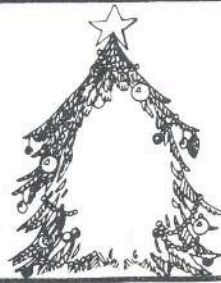

In and Out of Bondage

It is perhaps fitting that this issue of *The Covenant Message* should begin with a brief look at Christmas, December 25, which many believe was originally chosen to accommodate converts who celebrated the birth of the god Mithras or who kept the Saturnalia festival. This also coinciding with the Northern winter solstice festival and indeed with all the ancient religions which celebrated the rebirth of life at the beginning of spring.

It is interesting to note that the word "yule" comes from an ancient pre-Christian Anglo-Saxon word for merry-making. While the singing of joyful Northern European folk songs and the burning of large logs, the decoration and evergreen trees, symbolised the continuation of life. Christmas, as it is known today, first being observed during the third and fourth century and then only to encourage many of the heathen to adopt the Roman Catholic religion and because among these heathen there were those who had long celebrated the birth of a son to the Babylonian queen of heaven at this time. Thus, the month and even

the date covered many pagan ideologies.

Semiramus, also worshipped as Rhea, the great "Mother of the gods" was from all accounts a person of "unbridled lust and licentiousness" and atrocious rites identified her with Venus "the Mother of impurity" and Diana, the virgin and the patroness of virginity. The Ephesian Diana also being called the mother of gods.

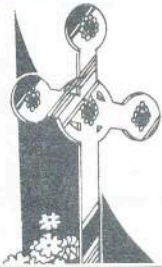
Further mention should be made of Mithras, the Persian god of light — the god of vegetation, of generation and increase who was regarded as mediator between humanity and the unknowable God reigning in the ether. His cult spread until roughly A.D. 275

but was still in existence as late as the fifth century having gained ground in Rome where it was both a political and philosophical force. However, it gradually became prohibited because of its cruel human sacrifices.

Many notable scholars such as the Rev. Alexander Hislop, maintain that Christmas is unquestionably a pagan festival. For instance, the Christmas tree was common to both pagan Rome and pagan Egypt where in the form of a palm tree, it denoted the pagan messiah Baal-Tamar while the fir tree of Rome denoted Baal-Nerith. In general, primitive people even today believe that there is life in all things such as stones, holes, tools, smoke and of course, in trees which must never be cut down without prayers and permission from either a beneficent or malevolent spirit.

The mistletoe bough was long regarded by the Babylonians as coming from heaven for grafting into an earthly tree. Thus heaven and earth were joined together, the mistletoe being the token of divine reconciliation to man, the kiss given under it, the token of pardon and reconciliation.





The candles should not be overlooked either for they too were part of pagan worship honouring the Babylonian god while those carried in a Catholic fiesta procession still today in many countries symbolise the rain gods being invoked and shown what is required of them. The colour red of course dominates at Christmas and red is the Chinese colour of good fortune. It also symbolises the blood — which has always been worshipped as life.

In 1915, R. le Forestier wrote of the revival of the *Order of the Illuminati* by Leopold Engel to which order a certain Aleister Crowley belonged. Crowley was called “A Master of Corruption” for his writings “are a strange medley of sexualism, mysticism, indecencies and blasphemies” — and subversive political activities. His god was the creative principle

and sacrifice was necessary to release energy. Thus he could write “The animal should . . . be killed within the Circle, or the Triangle, as the case may be, so that its energy cannot escape . . . For the highest spiritual working one must accordingly choose that victim which contains the greatest and purest force. A male child of perfect innocence and high intelligence is the most satisfactory and suitable victim . . .”

Without doubt this is satanical, pandering to neurotic and depraved minds who in turn contaminate others but Christianity is not blameless in that the ancient letter TAU — T in Greek, a mark or cross, is traced back to Nimrod and was used on the forehead of those “baptised” into the very pagan mysteries that men such as Crowley upheld.

Unquestionably, it is extremely

commendable to remember those less fortunate than oneself and for families to be united at least once a year, but it is far from commendable to add a “religious” flavour to this time and in doing so, bring the LORD God of Israel into disrepute.

To sum up and as history makes abundantly clear, within three hundred years of the First Advent, there was an infusion of Babylonian and attendant paganism with Christianity when Rome was officially declared “Christian” and the doors opened to all and sundry. And this in spite of the fact that the Lord Himself had stated He had no mission but to the “lost sheep of the house of Israel”. His mission being to teach the Law which totally rejects the Babylonian mysteries with their concept of the “son of the queen of heaven” as a universal “saviour”.

Thus, the only real and lasting “good time” will be when true Israel turns in obedience to the Law of the Lord. When the Son of the Almighty Yahveh of Israel, Yahveh’s Word Incarnate in the flesh, is “worshipped” in the truest meaning of the word.

Symbols and images were on display in August 1983, at the Sixth Assembly of the *World Council of Churches* in Vancouver and a report by John Whale of the *Sunday Times* mentions that these included the Cathedral-sized marquee in papal colours set up on the grassy campus of the University of British Columbia; an Indian totem-pole and the fast-selling ecumenical umbrella which is what the WCC symbolically puts up so that every enterprise is protected against any sense of wrong doing. In point of fact, ecumenical umbrellas were actually sold — ordinary ones with the Council’s device on them!

other hand was a gift from a group of Canadian Indians — animists and ancestor-worshippers. During the Assembly this totem-pole was lashed to the front of a five-storey theology building nearby waiting to be shipped to Geneva to stand outside the World Council's headquarters. As John Whale comments it will be "a scowling witness to the fact that the religious impulse takes many forms beside the Christian, some of them apparently just as durable".

The assembly also revealed other "images" and how far off unity is between the churches — although this time and despite their appalling record of quarrelsomeness — they did manage to get together thus tragically confirming that Westerners are now more ready than ever before to find merit in cultures other than their own — which of course, is the real purpose of this World body and now of Christianity itself. And it has been the incorporation of these various cultures which have unquestionably become the new image for worship.

Delegates to the assembly seemed to have had so many political, social and "human rights" issues to discuss that even after eighteen days they needed an extra two-hour sitting to finish the

agenda. There were scathing attacks on the Reagan Administration over Central America; a mild demand for the withdrawal of Soviet troops from Afghanistan but vigorous opposition to any type of military intervention by the United States.

The South Africans present called on member churches to attack *apartheid* on all fronts and to deepen their solidarity with the "liberation" movements and encourage economic sanctions. Bishop Desmond Tutu, the Black secretary of the South African Council of Churches was said to have shown a wonderful "charity" for White South Africans. "We

should indicate that the world churches love and care for them and are not anti-South African, but anti-apartheid", which may cheer some South Africans up somewhat? It certainly brought joy to the hearts of the World Council members for it provided them all with a prolonged and orchestrated forum and helped them gloss over the appeals made by the Russian delegates which appeals it was felt did more harm than good. In point of fact, the WCC dismissed the torture and oppression of the most powerful empire on earth today and so, there need be no serious doubt concerning the hypocrisy of this infamous Council, an hypocrisy which caused one reporter to remark that the churches which remain members of the WCC might think of fellow Christians in the Soviet Union, and remember the words of Christ: "... if his son ask bread, (of any of you that is a father) will he give him a stone? Or if he ask a fish, will he give him a serpent?" (Matt. 7:9).

"Yes, if he's anti-communist and asks the World Council of Churches!"

"It is an odd paradox of Christian history that those churches which seem most pre-occupied with the affairs of this world leave the least impression on it, whereas



those most pre-occupied with the next world have by far the greatest impact upon this one!" So wrote the publisher of the *Alberta Report*, August 1983, and compared men such as Charles Wesley with — "... the sadly ridiculous spectacle of the World Council of Churches. Christ, the council has apparently decided, was a somewhat mis-directed social reformer, (who) arrived before his time, whose chief bequest to the world was a kind of theological rationale for left-wing politics. They are therefore endeavouring to convert the church into an ecclesiastical branch of the Communist Party, armed not with truncheons but Bibles, nine-tenths of whose contents they would prefer that the faithful ignore. In Moscow, they must be a subject of great hilarity. Here, (in the West) they are merely a study in the absurd.

"Is there not something tragically comic, for example, in a clergyman from a comfortable North American suburb — his stipend adequate, two cars in the garage, garbage compactor in the kitchen, four weeks holiday with pay, his life secured by insurance and his freedom of speech by the cruise missile — equating himself with the Christian martyrs down

through the ages, because he 'dares to speak out on the social issues of our time? ...' And when he conceives of himself and his fellow left-wing parsons as right up there burning at the stake with the rest of the martyrs, this is not the vision of a prophet but the delusion of a fool. If the contempt and derision of the public and the press fall upon him for this, it is not because it is the nature of righteousness to arouse scorn but because it is the nature of the asinine to arouse ridicule ...

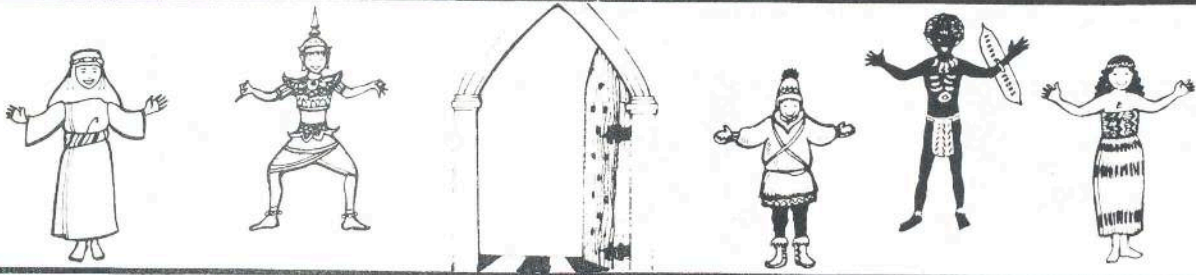
"Another absurdity of the *World Council of Churches* is that it has spent the last twenty years protesting, deploring and documenting the sins of the capitalist states, while quietly ignoring those of the Communist, in fact even financing Communist insurgents who have murdered Christian missionaries."

It is believed that most of the money for the WCC comes from West German and American churches but that the Soviet Union contributes secretly, much as they back the hysteria for U.S. disarmament — hence the adoption of a "theology of revolution"; why the Council is called an ecclesiastical United Nations and why the *Canadian Jewish News* could report of the

Vancouver Assembly: "Everywhere you go, you find Jews ... you might be excused your surprise at finding them speaking from platforms and participating in discussions, some of the latter even closed to the press.

"Surprise is no longer called for, however, since interfaith dialogue has now come into vogue among Christians, as much more than a tip of the hat to Jews. At the *World Council of Churches'* sixth assembly, interfaith dialogue, while far from being the central focus, has definitely won its place. For the first time, non-Christian guests have been made part of the proceedings, and it therefore marked the debut of Jews addressing a WCC assembly ..."

The new legitimacy of interfaith dialogue apparently resulted from a previous assembly meeting in Mauritius when it was decided to invite fifteen non-Christians as observers and so in Vancouver not only Judaism was represented but among others, a Hindu of the department of theology and religious studies of Leeds University in Great Britain was invited to address a meeting. Which if nothing else, reveals just how foreign religions are being catered for within Anglo Saxondom today.

As the juggernaut of the vast Socialist-Communist machine grinds its materialism over the nations, strangling not only the economic system but eroding civilisation itself, history points unerringly to the fact that the apostasy of the "social gospel" has contributed in no small measure to the giant strides being made. The World Council of Churches, in pursuing its Social Gospel in a Programme to Combat Racism, has shown very clearly that it is politically involved with revolution and terrorism.

In the 1969 Canterbury meeting of the Central Committee it was stated: "We call upon the churches to move beyond charity, grants and traditional programming to relevant and sacrificial action leading up to new relationships of dignity and justice among all men and to become agents for the radical reconstruction of society. There can be no justice in our world without a transfer of economic resources to undergird the redistribution of political power and to make cultural self-determination meaningful. In this transfer of resources a corporate act by the ecumenical fellowship of churches can provide a significant moral lead." This is socialistic.

Later, in the August 1972,

meeting of the Central Committee in Utrecht in the Netherlands and in Document 8 of the proceedings, the following appeared: "Never in the history of the WCC has a decision had such a tremendous educational impact on both oppressors and oppressed in the churches. After emotional outcries in some parts of the Atlantic community with expressions of a 'deep sense of shock and outrage' and accusations that the WCC was 'engaged in supporting campaigns of murder in Southern Africa' a more realistic debate evolved. Terms like 'terrorists' and 'guerrillas' changed to 'freedom fighters' and 'liberation movements'. The discussion established the necessary distinction between violence which represses and violence which liberates . . ."

With regard South Africa it has been stated: "The WCC must listen first to the voices of its oppressed African brethren and sisters. Among them an increasing number claim that the liberation movements are speaking for the Africans." The bias in favour of Blacks is all too obvious and a spill-over is constantly seen in every walk of life. Earlier in 1983, a request was made by a member of the White American Political Association for

U.S. El Cajon's City Council to declare a *White History Week*. This was refused with the remark that a *Black History Week* was justified but a week for White History was not.

Within the context of the programme to force all men, regardless of their particular individual wants and capabilities into a one-world, one-government, one-religion, totalitarianism the "social gossellers" are thus seen as an insidious tool and that they are deliberately aiding the spread of a system dedicated in its opposition to Almighty God and His Plan for world blessing. Many centuries ago, an Israelite Psalmist prayed that the Lord God would not remain inactive against a diabolical conspiracy which, he said: "... have taken crafty counsel against thy people, and consulted against thy hidden ones. They have said, Come, and let us cut them off from being a nation; that the name of Israel may be no more in remembrance" (Ps. 83:3-4).

The horror is found in that there are those of the same race in which true Israel is found who are joining in the "crafty counsel" of the conspiracy in order to destroy their own people. Such hypocrisy and such treason has surely never been matched in the long history of man? ■

The Cult of the Ugly

Writing a commentary is fundamentally different from writing an article on one given theme as always there is the question of space. Naturally, the most important aspects should be touched upon and in as simplified a form as possible but to cover every point which affects and has affected the lives of people today is to say the least, impossible.

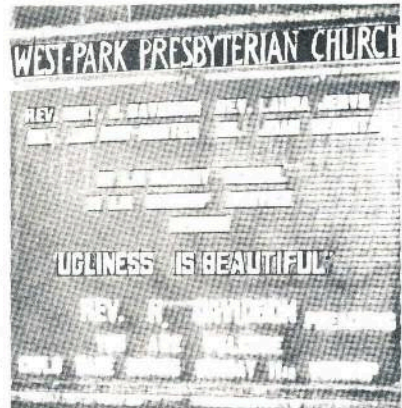
When it comes to the subject of *art* a combination of colour and movement or words and music would, without doubt, lend more reality and vividness for no matter how well written, this can never be achieved by the printed words of a short commentary — although in point of fact there have been amazing and even horrific results achieved by the printed word in ensuring the breakdown of Western civilisation.

It was John Ruskin who said many years ago: "Great nations write their autobiographies in three manuscripts, the book of their

deeds, the book of their words and the book of their art. Not one of the books can be understood unless we read the two others, but of the three, the only trustworthy one is the last." The question of the trustworthiness of art possibly still being true in Ruskin's day — before the turn of this century — but it is hardly true today.

What then *is* art? A skill, actions or activities generally considered as a skill? The skill of design; representation; the use of imagination. Art is called a creation; a human skill as opposed to nature but it is also called cunning, stratagem, a certain branch of learning. It is painting, dancing, architecture, sculpture, music and poetry. A form of self-expression and not always pleasing to others. George Bernard Shaw possibly thinking along these lines and of his own experience as a music critic when he wrote: "Hell is full of musical amateurs." However,

he may also have been thinking of Nero and Imperial Rome when the Romans were forced to close their eyes to orgies and murder while Nero twanged a lyre and sang to the wild applause of the guards unable to leave the theatre even for the most urgent reasons. Possibly this being the first recorded "musical" demonstration.



Works of art are part of history but are not always *the* history of civilisation. In his work *Civilisation*, Kenneth Clark believes that "great" works of art have been produced in barbarous

societies — so it all depends on what one considers as “art”. In fact, the very narrowness of primitive society gave their ornamental art a peculiar concentration and to use a generous concept — vitality. On comparing an African mask with the head of Apollo, Mr. Clark rightly states: “I fancy that most people nowadays, would find it (the African Mask) more moving than the head of the Apollo of Belvedere. Yet for four hundred years after it was discovered the Apollo was the most admired piece of sculpture in the world . . .

Superstition and cruelty also existed in the Graeco — Roman world but their images meant something to the people. Man felt there was something more than the day-to-day struggle. There was a feeling that there should be more time and thought given to the attainment of a state of perfection. Certainly something had disappeared — reason, justice, safety and security but even so — “The children of his imagination are also the expression of an ideal.” An “ideal” — if it can be called that which had become lost — and is still lost — although hopefully, not as yet completely destroyed.

It all happened before. At the time of the Roman Empire for instance and —

“ . . . thinking about this almost incredible episode does tell one something about the nature of civilisation. It shows that however complex and solid it seems, it is actually quite fragile. It can be destroyed. What are its enemies? Well, first of all fear — fear of war, fear of invasion, fear of plague or famine, that make it simply not worthwhile constructing things, or planting trees or even next year’s crops. And fear of the supernatural, which means you aren’t question anything or change anything. (Although today it is change which is a destroyer.) *The late antique world was full of meaningless rituals, mystery religions, that destroyed self-confidence. And then exhaustion, the feeling of hopelessness which can overtake people even with a high degree of material prosperity.* So if one asks why the civilisation of Greece and Rome collapsed, the real answer is that it was exhausted.”*

How strangely similar this sounds of Western civilisation now. And what or who — besides fear — are its enemies? Never forgetting the invasion of destructive alien cultures which have created their own particular brand of chaos.

However, it was Dionysus-Bacchus — the “god” who supposedly breathed life into ancient Greek works of art — who was to influence Isadora Duncan, that ill-



fated but wildly popular dancer, who behaved like a nymphomaniac and a street-walker. This was the time when “new” ideas were beginning to dominate the arts — the correlated movement of sound, light and moving masses — were still in embryo for photography in motion was only dimly sensed, but Isadora was believed to be eagerly groping for them. It may be that: “. . . all true art — (does) — strike to the heart; its audience sees and recognises as valid something that cannot yet be intellectualised and put into words.”* Yet so many who knew this woman saw her

life imperilled by weakness of will and self-indulgence — even when her children were drowned through an unbraked car they were in rolling away from the chauffeur into the Seine, dropping into forty feet of water, un-reached and unreachable.

And yet, Isadora danced on, meanwhile flitting from one affair to another until eventually dying by strangulation when her scarf wound round the wheels of the car she was driving in. Her life, with all its sordid mess, was the pattern upon which so many “artistic” lives were and still are built, as any modern film magazine will reveal. And these are the “gods” worshipped by so many young — and old — people in the Western world today.

The life and death of Isadora Duncan brings to mind film-star — or “goddess” — Marilyn Monroe linked not only to the late American Attorney General, Robert Kennedy, but to his brother, President Kennedy. This story is one of corruption, intrigue and bribery and as with President Richard Nixon, one of tape recordings of intimate conversations.

The Kennedy brothers risked scandal over and over again and according to the well documented work ironically labelled *Spooks*: “What

was at stake with the Monroe tapes was the political future of the Kennedy family. The American voter, while tolerant of human failings, would have been outraged by the promiscuity of the brothers, a promiscuity involving organised-crime figures as well as Hollywood decadents. It was, in short, a seamy and volatile situation brought about by an almost Hellenic character flaw in two brothers destined for tragedy and legend.”

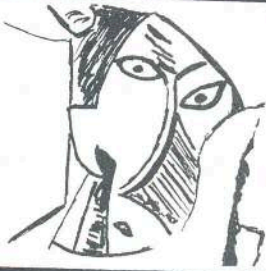
Meanwhile, the psychological warfare and the cultural aggression against the West continued with Richard McCulloch in his outstanding work *The Ideal and Destiny*, seeing the cultural intrusion by alien elements as striking at the very soul of the people, warping and twisting its character, personality and temperament. Pre-empted and diverted by the influence of aesthetic egalitarianism and primitivism through a cultural intrusion of African origin. And those who promoted the trend in art, dancing and music and in fact, in all the arts have been hailed as the avant-garde progressives of the artistic world. Those who have sought to cherish their own culture are castigated as old-fashioned reactionaries and ostracised from the pluralistic culture now dominated

by the so-called “new wave”.

Paintings, drawings, sculpture in bronze, wood, wire, tin, string, paper and clay. These were all items the Spanish artist Pablo Picasso used to extend what people are pleased to call his “talent”. Supposedly, Picasso had “flashes of demonic restlessness, heights of confidence — particularly in his earliest work — and depths of insecurity, the relationships (alternately loving and cannibalistic) to the art of the past”, but his was not a talent in the truest sense — or in any sense at all — but it was a cunning stratagem which of itself may perhaps be called art or better still, a skill.

It is said that when Picasso meant to paint a cabaret scene with figures at a table, the image mutated into still life leaving the drinkers’ legs fossilised in the sloping table legs. The great brown half-moon of the table top, the bread loaves and fruit and napkin having a plastic intensity — and gradually this jutting, sculptural quality dissolving in ever more complicated faceting “cubifying” — though there are apparently no real cubes in cubism.

Around 1918, Picasso found his first public among the intellectuals of Europe. Now it was that *revolutionary art* held sway and Picasso

threw himself into the role of maestro until apparently to his admirers, he “gave feeling itself and extraordinary, self-regarding intensity, so that the most vivid images of braggadocio and rage, castration fear and sexual appetite in modern art still belong to the Spaniard” — who never cared about civilisation or its discontents but saturated a motif with “meaning” to the point where it could hold no more truth — although it never held truth at all. The above sickening description revealing what type of perverted truth is in existence today.

The following Picasso statement is said to be genuine — it certainly appeared in the *Daily Telegraph* and other papers — and was taken from the journal *Libro Hero*, edition Vallecchi, Florence, November 1951,

pages 265-268. Picasso said: “From the moment that art ceases to be the food that feeds the best minds, the artist can use his talents to perform all the tricks of the intellectual charlatan. Most people can today no longer expect to receive consolation and exultation from art.

“The ‘refined’, the rich, the professional do-nothings, the distillers of quintessence, desire only the peculiar, the sensational, the eccentric, the scandalous in today’s art. And I myself, since the advent of cubism, have fed these fellows what they wanted and satisfied these critics, with all the ridiculous ideas, that have passed through my head. The less they understand them the more they admire me. Through amusing myself with all these absurd fancies I became celebrated very

rapidly. For a painter, celebrity means sales and consequent affluence. Today, as you know, I am celebrated; I am rich.

“But when I am alone I do not have the effrontery to call myself an artist at all, not in the grand old meaning of the word. Giotto, Titian, Rembrandt, Goya were great painters. I am only a clown, a mountebank.

“I have understood my time and have exploited the imbecility, the vanity, the greed of my contemporaries. It is a bitter confession, this confession of mine, more painful than it may seem. But at least it does have the merit of being honest”, which, one supposes satisfied Picasso but nevertheless his “art” mocked and destroyed the concept of all that was beautiful in the truest sense for Picasso became the pacesetter, a reflection of the permissive society of today which unquestionably propagates the cult of the ugly and which is destroying our people. “The culture they originated no longer belongs to them and no longer considers them worthy of concern.”

Music



Pluralism is the system which recognises more than one ultimate principle while to pluralise is to make plural, hold more than one benefice — or so the *Reader's Digest* dictionary maintains. Of benefice — strangely enough — the same dictionary simply states “Church

living”! Which could imply that the present pluralistic culture now being created, somehow or other stems from the social gospel of the modern church? The incorporation of every one — irrespective of colour, race or culture — into a one-world religion and in this context,

the influence of the alien can increasingly be seen. The Africanisation of the art and music of the Western world has, on the other



hand, led to distortion and a pluralistic sound far removed from the music which previously was part of Western tradition.

Having no melody or harmony whatsoever, African "music" is simply a wild and grotesque beat which, many years ago, brought the remark from the explorer and medical missionary, Dr. Livingstone, who on viewing the contortions of the African dancers, stated: "If the scene were witnessed in a lunatic asylum it would be nothing out of the way, and quite appropriate even." Yet there is so much more for, as was made obvious at the time of the Mau Mau revolt in Kenya, the "music" of the African has a hideous feature which few Europeans understand.

Writing of how the recruiting to this subversive organisation was achieved — an organisation whose leader, Jomo Kenyatta, was later welcomed in Britain by the Queen — A.K. Chesterton noted: "It is impossible to describe in a book (*The New Unhappy Lords*), what took place on these occasions, because those who took one or other of the Mau Mau oaths, especially those who aspired to the higher ranks, were required to engage in the foulest sexual malpractices... the idea being, ap-

parently, so to degrade members of the cult that... they were conditioned to engineer or participate in infamies fouler than this century has ever known... The Mau Mau conspiracy was the most diabolical rebellion of our times — this was of course, before Rhodesia — and was conducted in such a way that one would not have been surprised to learn that the Devil himself had managed it."

Constantly in the background of all African affairs are the drums and the high shrill whistling of the women exciting the men into sexual frenzy and madness. Now this beat is embodied within the music of Western man and significantly, the word *funk* constantly used to describe this noise is a word which means to be in a state of terror; to flinch; to shrink in fear or cowardice.

To be afraid of; to shirk; to try to evade; to frighten; to scare. *Blue funk* is *abject terror* — and this is now the daily diet served up by every possible means for White youngsters to digest.

Then there is *reggae* which defies description but a *reggae dub* is the treatment of a basic piece of music with echo, reverb, distortion while *dub* on its own is apparently what an abstract is to painting. Unintelligible. Rock music unquestionably promotes and feeds on drugs and illicit sex. Indeed, "our young people are high on drugs and sex because their music is high on drugs and sex".* And a well known American Congressman could state: "Drug abuse among our children has risen, in the past two years, from epidemic to pandemic proportions. It has grown so large that neither this nation — nor any nation in history — has ever before faced a problem that is so insidious and so dangerous. And if we don't recognise the importance of this problem, it will have disastrous effects upon our society."

Derek Taylor, press officer to John Lennon and the Beatles who were heavily involved in drugs and Hinduism, remarked: "It's incredi-

ble, absolutely incredible. Here are these four boys from Liverpool. They're rude, they're profane, they're vulgar, and they've taken over the world. It's as if they had founded a new religion. They're completely anti-Christ. I mean I am anti-Christ as well, but they're so anti-Christ, they shock me, which isn't an easy thing to do." And since the Beatles, the situation has deteriorated even further and we are confronted with the "ceaseless, incessant, pounding propaganda in the ears and eyes of the young, promoting fornication, mysticism (the occult), marijuana, and violent revolution, and we are at the point where young women seek roles as 'urban guerrillas' and others feel 'pregnant with murder'."*

Those who maintain that modern music cannot possibly be as dangerous should note that the lead singer of

the Rolling Stones maintained: "We are going for the minds of people now. So are most of the newer groups." The theme of this band being sadism. The deriving of perverse sexual pleasure from the infliction of cruelty. Other groups are committed to witch-craft, homosexuality and the occult while one of the most disturbing of all things to emerge of late is a method called "Back Tracking". Often when a record or tape is played there are strange sounds mixed into the track. Strange until played backwards. Then the message is clearly understood especially if one is high on certain hard drugs. A frightening aspect of this however, is that psychiatrists are convinced that the backward coded messages although not heard during normal playing, can be and are decoded by the subconscious mind. During tests conducted, a recording, "Another One Bites The Dust", was played to teenagers until they knew it by heart. Less than half-way through the session a serious-minded girl who did not smoke at all began to try marijuana (Dagga Pot Weed) and could not understand why until part of the song was played backward. Clearly and loudly came the words, "O.K. we are going to smoke marijuana." Another Ameri-

can group have a song "The Day Electricity Came To Arkansas". In the middle, during an interlude there is an unintelligible sentence. Played backwards it says: "Satan, Satan, he is god."

"I'm convinced rock music is creating a cultural climate that could see homes burned, people murdered, rapes, incest, transvestism, homosexuality, sex with the dead, sadism/masochism — all could become commonplace in our society as a result of our failure to clean up the music that dominates every strata of our youth culture. It's like raw sewage.

"Just look at the evidence. The drug epidemic from which we have suffered for fourteen years was created almost single-handedly by rock musicians like the Beatles in the late 60s and early 70s. The new plague, though it will include the traditional drugs, sex, and revolution; will be characterised by the vilest, grossest, perversion imaginable. Millions will wish their children and grandchildren were back on drugs.

"A young minister contacted my office with 'raw' research data indicating exactly what I have just told

you. Since that time, I have been keeping my own eyes open just to see how really bad it is. What I have found has left me chilled to the bone:

"Current million seller albums in which male musicians dress in women's clothing and sing songs like, 'When the Whip Comes Down'. "The crisis in young people's music is far worse than I ever thought possible, and every reader must help solve it before it creates a moral sewer from which we will never recover. America and the West might survive a military attack, but it can never survive the abject perversion of an entire generation of its finest young people."

This *Special Bulletin* may appear shocking to many and many may contend it should not have been printed in *The Covenant Message* but recall again the Mau, Mau atrocities for these are exactly the same atrocities now being demanded of our young people. 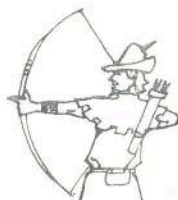

WHAT SHALL WE EAT?

In the November 1983 issue of The Covenant Message the first of our Health articles under the above title was published with the promise to continue this important series in the December copy. However, the vast amount of research into this vital subject has made it impossible to produce the next article in this issue without a considerable amount of data being left out and, rather than this should happen, it has been decided to continue the series in the January 1984, Covenant Message. Meanwhile, the following is presented for the interest of the readers.

Sport

"In merry England in the time of old, when good King Henry the Second ruled the land there lived within the green glade of Sherwood forests, near Nottingham town, a famous outlaw whose name was Robin Hood. No archer ever lived that could speed a gray goose shaft with such skill and cunning as the sevenscore merry men that roamed with him through the greenwood glades. Right merrily they dwelled within the depths of Sherwood Forest, suffering neither care nor want, but passing the time in merry games of archery or bouts of cudgel play. . . . Not only Robin himself but all the band were outlaws and dwelled apart from other men, yet they were beloved by the country people round about, for no one ever came to jolly Robin for help in time of need and went away again with an empty fist."

The particulars of Robin Hood's long and celebrated career have a distressing contemporary ring to them: an upper class dropout (according to some reports) whose "wild and savage disposition" led him afoul of the law. Robin ran off and set up a sort of commune

in the woods, lived in high style off the land, and led a modest but effective campaign of guerrilla warfare and terrorism against the ever-benighted Establishment of the oppressed proletariat. Strangely, there is seldom any hint of wariness toward the band's subversive nature



even though every school boy knows there is more to it all than anyone is telling. The bad guys, the Sheriff of Nottingham and his men, are the obvious figureheads of legitimate authority (parents) and yet there is always a way to defy them, escape to a camp sanctuary on the

outer fringes of civilisation, safe from rules and reprisals, where everyone has a good time and where no girls are allowed.* Plus — as a bonus — there is always sport.

The trouble is that just as none of the ballads tell us very much about Robin Hood himself so too not a great deal is known about the sport heroes of today. What they are really like aside from being able to play this or that game extremely well. Undoubtedly most sports also have their "merry men" who unfortunately, seem to do more than just make things a bit uncomfortable for the "Sheriff of Nottingham". In fact, British soccer fans are the terror of Europe whenever a local team plays abroad, especially in championships. The police expect a riot and are seldom disappointed.

It is claimed that in North America, the football season brings out enthusiastic fans but that in Britain, the soccer season brings more than a little unpleasantness.

Things were certainly serious — one team manager wanted vigilante patrols to battle soccer's hooligans while another wanted to bring in the dogs. In South

Africa, the barbed-wire fences and the dogs also being a very necessary protection.

Nor of course, is soccer the only sport affected — and here it should be explained why sport has been placed under the heading of Health. For some strange reason there still remains the belief — growing ever fainter — that sport generally is good for one but suddenly and almost without knowing it, sport has become corrupt, dishonest, venal, exploitative, lecherous and immoral in a dozen different ways. And the point is, will the sporting public continue to blind themselves to this and continue to offer excuses, or will they make some effort to see that there is reform? For the circumstances which now exist are certainly not healthy.

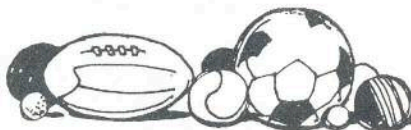
"You will not ask about Martina's sex life. You will not raise the subject of lesbianism. And you will not discuss bisexuality." Thus began the sermon handed out by Wimbledon favourite, Martina Navratilova's very protective press agent. The one half of her "protection squad" being her coach, Renee Richards, formerly known as Richard Raskind while her best friend makes very obvious territorial remarks around the star. So

much for this particular "idol".



It is important to note as well that when a tennis player lifts up his wristband to his face during a match, he may be mopping up sweat. But he could be snorting cocaine. This was revealed in an article by Michael Mewshaw who was told by a top American drug expert that some players dust their wristbands with cocaine and take occasional snorts to perk them up for crucial points. In fact, Dr. Robert Millman, Director of the *Drug and Alcohol Abuse Programme* at Cornell University admitted he is treating players from the world tennis circuit. While a top umpire remarked, "Tournaments are thrown into a panic if a director can't come up with the drugs a

top seed wants.”

“The money and glamour of tennis brings players into contact with entertainers and celebrities who are heavy users of coke. Many players dabble with drugs to imitate them or to help cope with the pressures and anxieties of the sport.” Then there are the bribes for big games for the one thing a tennis tournament director wants more than anything else are the top stars — McEnroe, Lendl or Connors and many directors will go to great — and illegal — lengths to obtain the stars they need. So players often receive between 50 000 and 100 000 dollars “under the table”. The players mentioned have all denied receiving bribes but then, not all guarantees are money.

“... men of huge physical gifts, with great dedication to the perfecting of their athletic arts. They have much in common, most obviously that they are Black ... and they are the new idols of American sport culture.” Indeed, to millions of U.S. sport fans, the trend is incontrovertible. The image of the star sportsmen is increasingly, a Black image!

However, even in America racial differences — both physical and cultural — have been noted although not necessarily used as “excuses for discrimination”. Physical

differences *do* exist and questions *do* uncomfortably arise. For instance, does the apparent superiority of so many Black sportsmen mean Blacks in general are better sportsmen than Whites. If so, why?

The Blacks themselves seem to have no problem answering this question. “We are built a little differently for speed, high buttocks are all characteristics of Blacks. All the Blacks seem to have bigger hands, jump higher.” Psychologist Eleanor Metheny, who conducted studies of American Blacks forty years ago, found that, in general “Blacks had longer legs relative to total body length and that lower legs were proportionately longer, while thighs were shorter but more muscular than those of Whites. ‘In jumping, the longer leg is evidently an advantage,’ Metheny wrote. Subsequent research, while limited, seems to confirm Metheny’s findings.

“According to Edward Hunt, an anthropologist at Penn State University, young Blacks tend to have lighter trunks and heavier limb bones, lungs a little smaller relative to body mass and less body fat than White youths. These characteristics, combined with relatively longer limbs and hands, should be helpful for sports

that require quick movement, though they may well put Blacks at a disadvantage in swimming”*

It seems that Black tennis player, Arthur Ashe, was not too happy with the idea of Black superstars being the idols of Black youngsters — although he didn’t mention White youngsters — and called upon them to spend two hours in the library for every hour on the sports field. “We have been on the same roads — sports and entertainment — too long. We need to stop, fill up at the library and speed away to Congress and the Supreme Court, the unions and business.”

Then, still expressing what many Blacks feel is true — and what Whites are apparently and tragically coming to accept — he predicted: “Don’t worry, we will still be able to sing and dance and run and jump better than anyone else.”

Sport today is thus also being used to destroy our people and their heritage. Unquestionably, there is something very unhealthy about the present situation. And it is a situation which needs to be carefully watched. For it is not only through the obvious that a people are destroyed.

Contact Disease

During 1983, Western society was bombarded by articles dealing with the deadly disease called AIDS and of this it should be stated very clearly that because, in defiance of the Law of the Lord, we allow the deviates to practise their perversion in our society, it is not surprising that such diseases are now on the increase.

According to the Directives of the LORD, all such perverts should be put to death but, because we permit the sodomist among us and accord them "Human Rights" in their sub-human behaviours, each and every one of us, are now the victims of fear — the deviates from the fear of death for there appears to be no known cure for AIDS — while the people fear the possible contagion of the disease.

Significantly the LORD said: *"If ye will not hearken unto me, and will not do all my commandments; And if ye shall despise my statutes, or if your soul abhor my judgments, so that ye will not do all my commandments, but that ye break my covenant: I will do this unto you: I will even appoint over*

you terror..." The word *terror* translated from the Hebrew BEH HAW LAW which literally means "panic".

When the story of the giving of the Law at Sinai and the re-giving of it just prior to Israel's entry into the land of Canaan is recalled, it will be remembered that one command runs through it, a very persistent command in the context of obedience. *Israel was to remain separate from other people.* This may seem a strange point to bring up in a consideration of AIDS but it has a great deal to do with the common melting pot now called Western society. It may not be called "Christian" but that is beside the point for the LORD was specific as to who could be incorporated as a member of the true Israel community — and who could not be allowed in. Unfortunately or possibly intentionally, the English translation blurred over the distinctions and used one English word as the equivalent of four different Hebrew words — GER, NOKRIY, TOWSHAB and ZUWR. Their meaning being determined by the context in

which they were written. The GER was permitted full Israel rights. The NOKRIY — generally the Canaanites, Moabites and Ammonites — had no rights whatsoever and were classified as the "mamzer" or bastard. The TOWSHAB, a comparatively late word covered people whose only rights were in respect of justice while the fourth and final word ZUWR covers people such as racial aliens who were forbidden within Israel society. The one English word used to cover all four Hebrew words being "stranger".

Today, true Israel as found among the Anglo-Saxon and kindred people of the Western world are in the same position as Israel of old for, because of their religious and political leaders, they see no harm in the presence of prohibited aliens in their midst and the AIDS disease is not only a by-product of sodomy — which it certainly is — but is a by-product of racial intermingling. It is certainly significant that sodomites constitute 71 percent of all known AIDS cases but sodomy is not new — it has unfortunately been in existence long before it



was given social respectability by a permissive society — but prior to 1978/79 the *Acquired Immuno Deficiency Syndrome* was unknown. Thus, something has been introduced fairly recently which, for some reason, has struck at the perverted section of our society — and this “something” must be isolated in order to determine what is creating such panic in the Western world.

The trail seemed in the beginning to lead to Haiti with the Haitians becoming as popular as “pigs in a synagogue”, especially as far as Americans were concerned. However, AIDS began to make its appearance in Western Europe with France reporting 39 cases with four out of five never having been to America or Haiti. Then Belgium announced they had 35 cases — none of whom had had any contact with Equatorial Africa.

According to a news report, the first AIDS case in Belgium was a Zairean woman who had married a White Belgian — she died of the disease in 1981. With persistent investigation since then it has been revealed that Zaire is an endemic zone for the infectious agents of this disease. The significant feature being that Zaire is not known for homosexuality nor for drug users

— two high risk elements among Europeans.

The question then is — and possibly medical experts may answer this in the future — could AIDS be a double warning by the LORD of the consequences of continued national rejection of His Commands concerning the alien and concerning a social permissiveness which accords respectability to that which the LORD calls an abomination?

The LORD will *not* be mocked. He is *not* a “mythical god of love” as so many proclaim, turning a blind eye to those who persist in breaking His LAW. Besides the deadly AIDS and again because of declining morals, an epidemic of cancer in women was also reported in Britain during 1983.

Dr. Margaret White, a Croydon family doctor and trained gynaecologist, commented on a report in the British Medical journal of a three to fourfold increase in pre-malignant conditions discovered in women given cervical smear tests over 15 years. The trend towards an epidemic was undeniable.

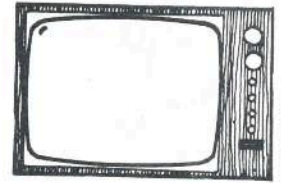
Dr. White believes: “It shows that AIDS is not the only serious sexual disease affecting that section of the population who copy sexual mores portrayed so explicitly night after night

on television.

“When I was practising gynaecology it was almost unknown for women under 40 to get cancer of the cervix. Now it is found in women in their twenties, and the terrible thing is that it progresses much more rapidly in them. You have cases of girls of 19 with positive smears who are dead by the mid-twenties.

“There was no doubt of the link between precocious, promiscuous sex and cancer of the cervix. Once it was thought that the circumcision of the husband protected a wife, because the disease was so uncommon among Jewesses. Now reports are that Jewesses are getting it, so it just seems they were protected in the past because they were more faithful than Christian women — now they aren't. Vast sums of money are spent on educating children about the dangers of tobacco and alcohol — with which I agree. But they are left in ignorance of the dangers of sex.” Dr. White has been leading the fight for parents to be told when their underage daughters are put on the pill.

Recall again the words of the LORD: “*If ye will not hearken . . . I will do this unto you: I will even appoint over you terror.*” ■

No New Thing Under the Sun

What will the world be like tomorrow? This question is now constantly asked as more and more "protection" schemes are set in motion by more and more concerned people while in 1980, the three volume, *Global 2000 Report*, was published in the United States by the *Council of Environmental Quality* and the Department of State. This report, requested by President Carter, projected world population, resources and environmental conditions up to the end of this century if present policies continue and represented "the first U.S. Government effort to look at all three issues from a long-term global perspective that recognises their inter-relationships and attempts to make connections among them."

The major findings of the *Global 2000 Study* was that the ability of biological systems to provide human needs may be expected to erode rapidly during the next few years and the recommendation was to initiate *new programmes for more effective family planning, resource management and environmental protection* — in order to ensure that social progress and economic

development are sustainable.

Mention has been made of this — what can only be called "diabolical" report, *Global 2000* — in several issues of *News of the New World*, sister magazine to *The Covenant Message* for, while on the surface it appears to be genuinely concerned with the earth's soil, atmosphere, plant and animal life, running throughout is the question of *population control*. And while there is indeed a genuine need to view the growth of the Coloured races with alarm it must be recognised that every attempt to decrease world population figures has been aimed at the White race who have tragically fallen for this propaganda. Willingly submitting to enforced racial suicide.

Thus the principal lesson to be learned is that new development paths *must* be explored and people everywhere *must* be prepared to adopt radically *new life styles, more in keeping with man's new circumstances*.

There is even more. Apparently, the question is whether *decision-makers have the foresight, the wisdom, and the courage to adopt bold new policies, which will clearly require unpopular sacrifice and constraint* — in time, so the report threatens — *to avert ecological disasters of global proportions*.

As this *Covenant Message* research report is being drafted, two TV films are entertaining thousands of South Africans in their homes. It is more than possible that both have been seen in other Anglo-Saxon countries as generally, this country is about ten years behind in its TV viewing. The



one programme is science-fiction dubbed into Afrikaans and the other is *Ark On The Move*, a Durrell environment and animal protection series which is excellent viewing material until one appreciates the repeated theme of animal adaptation and evolution. In one of the series a giant but sedated gorilla is shown with doctors and dentists intent on their examination of this anthropoid. In passing and almost casually, it was mentioned that not only was a blood sample taken but a sample of the animal's sperm as well.

The science fiction TV series on the other hand is at first glance merely another type of "Star Wars" with amazing satellites and futuristic planes weaving around the universe. Naturally there is an enemy who must be defeated at all costs. This appears to be an updated Mickey Mouse, Pluto or Donald Duck feature, a "sophisticated" cartoon for the children which undoubtedly it is with its half-human, half-animal characters who not only talk but obviously have an extremely high I.Q. Children already brought up on animated cartoons will readily accept this concept of animals who are like humans — and even humans with two arms and other defects.

One other feature of this particular TV film which should not be overlooked is that the President of this world galaxy is a woman. Women's Liberation has won. Now women are no longer

feminine, no longer "subservient" to men, willing mixing with every other race including the animals that talk. And she is certainly not motherly now. In fact, it is possible that her present demands for free abortion in order to have "full control over her own body" are no longer necessary at all.

"Take a cell, practically any cell, from your body, the theory goes, and through appropriate biological tinkering you can cause it to grow into a duplicate of yourself — identical eye lashes and toenails. No need for procreational sex any more; with this system, you can neatly reproduce yourself without a partner. Human cloning, it's called."*

Science fact or science fiction? Fantasy or reality? A molecular biologist maintains that "knowledge of genetic engineering is emerging that allows scientists to tinker with *and change*, the very stuff of life".

Already the first brain-cell graft is on its way and it is maintained the transplant would involve only a few thousand brain cells to begin with. In their animal studies members of the experimental team squirted a syringe of cells containing dopamime from a healthy foetal brain into an animal with a man-made brain disorder. The experiment appeared to work. Certain

brain cells in rats and monkeys have already been transplanted and in time, the same procedure on humans will be tried.

Genetic engineering hit the headlines during 1983 and is certainly under review. It is believed that within a few years doctors should be able to make an impact on some hereditary diseases for every human cell carries a blue-print of the genetic code for the adult (this is the theoretical basis for cloning) and it is believed that in time it may be possible to remove recessive genes in vitro from either sperm or ovum.

Dr. Robert Edwards, who pioneered test tube babies, has proposed that cells could be taken from embryos for bone marrow transplants. He maintains that the assumed rights of the 14 day embryo should be subservient to the interests of living children. Others too believe that the pre-implantation embryo does not merit the same respect as that given to a fully potential individual.

In April 1983, doctors were given permission by the *Royal College of Obstetricians and Gynaecologists* to carry out experimental research on test-tube baby embryos up to 17 days old. The College backs both the freezing of human embryos — and experimentation with spare embryos, the reason for the programme apparently being to check for abnormalities.

At least 112 "test tube"

babies — conceived in laboratory dishes not test tubes — had been born by the beginning of 1983. Researchers are edging into freezing fertilised embryos, transferring eggs from one woman to another, using donor sperm for fertilisation and some “pioneers” are actually “getting nervous and demanding a code of conduct”. One question raised concerning the possibility that children might be born from frozen eggs and sperm long after their parents had died. Other researchers however would not hesitate — indeed, have not hesitated — to use a surrogate womb for somebody who does not have a uterus or — cannot or will not carry a pregnancy, but wants a child. Eggs can be taken from a woman without a uterus, fertilised by her husband and placed in the womb of a second woman who agrees to carry a child with none of her genes. Already however, a few surrogates have refused to honour the contract and give up the children.

Multiple egg production has brought the contention that discarding fertilised eggs in the laboratory is the equivalent of abortion. Most doctors say they return all implanted eggs to the would-be mother but others admit that this is not always the case. Apparently, the mother has a choice. Doctors can fertilise the number the woman wants transplanted back, all the eggs can be fertilised with the husband’s sperm and additional embryos can be frozen — as spares to be

implanted later if the first attempt fails. Many couples will opt for donating an egg to an infertile couple — to assist another woman — or — and this is the ghastly possibility — for creating a centaur? The mythical creature which is described as “fabulous” — with its head, trunk and arms of a man joined to the body and legs of a horse — or could it in future be an ape?

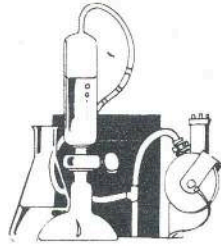
It is said of the Centaurs that they were not always like this. The first representation showing them as giants with hairy bodies; then they were depicted as men with the hind-quarters of a horse. Their definitive appearance is said to go no further back than the period of Phidias (5th c. B.C.), known for his statues of gold and ivory. The behaviour of the Centaurs was believed to be rude and barbarous. They were gross creatures, cruel and given to lechery and drunkenness — but not so the creatures in the TV science fiction series now being seen on South African screens and not so the ape which Durrell described as a wonderful animal even while repeatedly mentioning adaptation and evolution.

Of cloning it has been asked why all the fuss over a few laboratory frogs — using cells taken from tadpoles (equivalent in development to human embryos). “Because”, says Jeremy Rifkin, co-director of a public interest lobbying group and co-author of the book *Who Should Play God?*,

“The potential for human cloning challenges our entire value system.” And our very existence as human beings — after our own kind.

In 1978, the U.S. *Court of Customs and Patent Appeals* ruled that any corporation that creates a new form of life in the laboratory — in this particular case, a bacteria for cleaning up oil spills — can patent it. And as the authors of the *Reader’s Digest* article ask: “Does this mean that whoever is first to clone a human can patent the process? And is a clone then a possession, a product? What would be its legal rights? Could you keep it on hand like a robot — maybe even use it for spare parts?” For religionists the question would be with regard to the possibility of “salvation”. For the politician and those who want a one-world society it would mean the final victory.

And if instead of a “twin” human being there was a half human, half creature — what would be the position then? Certainly human population control and environment safety for animals, but not as the ordinary man-in-the-street envisages this. The article on cloning maintains that to restrict cloning-related research would mean — “closing the door on an important area of knowledge”. To continue to probe the secrets of the cell would be to uncover the secret of human cloning and so much more. And, given the nature of man, if it can be done it will



be done.

Techniques learnt in test-tube baby work may *make it possible to develop a new species of human being with fish-like gills to colonise the oceans*, a conference on in-vitro fertilisation were told in May 1983.

Dr. David White, Senior Research Fellow at the Department of Surgery, Cambridge University, said the manipulation of human genes would *make it possible to produce a "fish man"*.

Dr. White, addressing a conference in London called by the *Order of Christian Unity*, made a number of "Brave New World" predictions of the developments that would follow from test tube baby work. "If some of them sound horrific, I can only apologise and say that this is nevertheless the way scientists see the future as it may develop."

It was in fact, already possible to clone almost limitless numbers of identical babies by separating cells from a fertilised embryo in the laboratory. It was also possible to keep banks of frozen sperm, and it might one day be suggested *that all males should be compulsorily sterilised at 16*.

"If that sounds far-fetched, please remember that every piece of beef you eat is the result of that kind of manipulation."

In the near future genetic defects would be diagnosed in the embryo so that conditions such as haemophilia or diabetes could be eliminated.

The process would be achieved

by taking a few cells off an embryo, which would be put in cold storage while the sample cells were analysed. "If you are happy that the stored embryo has no genetic defects you can then thaw it and implant it."

It would also be possible to determine the gender of a baby in advance, but this caused fears by scientists that an imbalance in the sexes would result through an excess preference for male babies.

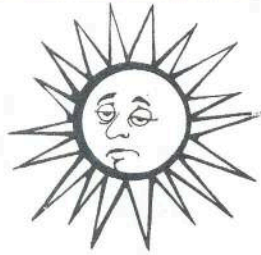
In the more distant future, it would be possible to produce "germ line cells" which would signal damaged organs to regenerate in the same way that salamanders can grow a new tail. This would have a valuable application for kidney patients, for example.

Prof. Jerome Lejeune, a leading geneticist from the University of Paris, said it might even be possible to grow a baby outside the body for a full nine months. Ectopic and other abnormal pregnancies showed the baby did not need to be inside the womb

to survive. All the embryo required was a fluid supply, normally provided through the blood of the mother. In future, an artificial fluid might be developed and a baby grown in a test tube for nine months.

So, when reports appear bemoaning the population explosion or declaring the next decade will be crucial for wild-life because there is just about enough habitat left to ensure continuity for wild plants and animals — and when one is told that future generations are likely to judge harshly if through the loss of these different species they are robbed of their birthright or it has been tarnished beyond repair — it will be well to recall that the LORD knew full well that the imagination of man's heart is evil. And He stated of this: "... *my people would not hearken to my voice, and Israel would none of me. So I gave them up unto their own hearts' lust: and they walked in their own counsels*" (Ps. 81:11,12). With what devastating results. ■

A Sense of Relief - or Foreboding

Having completed the research needed for the various items dealing with religion, art, health and so on, there was almost a sense of relief in the Research Department. Surely the political world could not reach the depravity as revealed in many of the study notes on themes which it was so necessary to expose? And expose, not for sensation but in the sincere hope that somehow or other, our people in all their lands could be jarred into reality. few years. Naturally, White New Zealanders were being blamed.

Just why a Canadian was involving himself with New Zealand is a mystery for in Canada there is racial strife as well due to a *socialistic* government and a *socialistic* immigration policy which seeks to destroy Canada by introducing every conceivable type of alien.

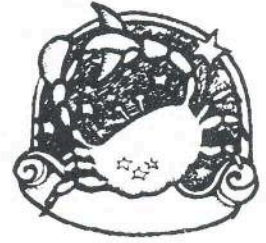
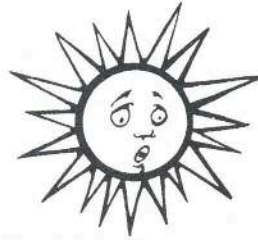
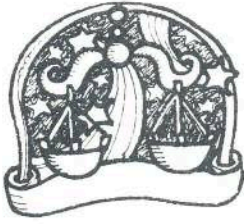

By far the most profound idea that has impregnated human thought in this century is that of synthesis. We see this idea manifest in the 'One Earth' concept of the *environmentalists*. We see it as the underlying motivation that gave birth to the United Nations. We see it at work in the movement for universal *human rights* as well as in the *ecumenical* movement which 'graces' the world's churches. We see it in the *scientific* world as physicists discover that the laws of the universe *lead more and more toward unity*, 'unbroken wholeness', rather than toward separate and independently existent parts. We see it in the fight for *racial and sexual* equality as we struggle to find what binds us rather than what divides us. And we see it in the search for true peace, (sic) because

we are now learning that to wage war on other people is to wage war upon ourselves — that we are in reality one people." But which people? What type of people or creature? And under whose control?

The iniquitous *World Goodwill* organisation is situated in England and Switzerland but also in the equally iniquitous United Nations Plaza. And they are now everywhere awakening the brotherhood idea — LOVE. One works with the masses, another with the churches. Yet another is in healing, welfare and philanthropic world movements, such as the Red Cross. There is a regent for music, painting and drama and two are English Masters; one in Britain who guides the Anglo-Saxon race and is behind the Labour Movement throughout the world and he also guides democracy.

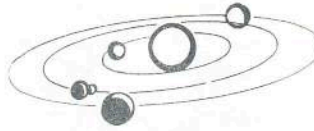
This is illuminism and the United Nations is in the very heart of this evil conspiracy and to such an extent that the *Don Bell Report** of September 30, 1983, could ask *Why Resurrect The United Nations?* "John the Revelator wrote of a beast with seven heads, one of which was 'as if it were wounded unto death' but was healed and then 'there was given unto him a mouth speaking great things and blasphemies'. In our mind's eye we can see

a resemblance between the two which makes it seem that the United Nations could be considered a rough copy of that beast of Revelation. With the UN, six of its heads (the double Triad) are autonomous agencies: IMF, World Bank, Gatt, IFC, UNESCO, and UNICEF. All these, since their very inception, have been busily drafting declarations, conventions, treaties and in other ways writing international laws and pouring out taxpayers' money, each performing its assigned duties as a part of the 'Piecemeal Functionalism' which is to create the One World Government. But the principal head, the United Nations itself, had been largely written off and declared virtually dead except for its use as a debating society. This is partly because the five-nation veto power of the Security Council renders impossible any really important action; partly because the one-nation, one-vote scheme (except in the case of the USSR which demanded three votes), is impractical when any one mini-state has the same power as a Western, civilised, industrial Nation; and partly because the UN General Assembly is so loaded with have-not Nations and Communist sympathisers that any worthwhile action would be impossible by a

General Assembly vote.

"So, the New World Planners had given up on that seventh and most important head of the UN which had been 'wounded unto death', admitting that it could never serve as a World Government. And new ways were sought to fulfill their plans. That's when the programme of 'Piecemeal Functionalism' was adopted, using the six remaining heads of the UN as Cabinet Departments of a new World Order. However, a little life was given the UN itself when Willy Brandt's blueprint for a *New International Economic Order* was accepted and promoted. And now President Reagan himself has given the East River Spycamp a new life by using it as a forum to appeal for aid in matters that should be handled by the United States Government itself. This in spite of Deputy Ambassador Lichenstein's candid statement that 'The United States strongly encourages member states (of the UN) to seriously consider removing themselves and this organisation from the soil of the United States. We will put no impediment in your way. And we will be at dockside bidding you a fond farewell as you set off in the sunset'. Fearing a national standing ovation for the Ambassador, the State Department and

the White House rushed to smooth ruffled feathers and to assure the Soviet delegation that Lichenstein was speaking for himself and not for the American government. But 24 hours later President Reagan was forced to try to save future votes by saying: 'I think the gentleman who spoke the other day had the hearty approval of most people in America in his suggestion that we weren't asking anyone to leave, but if they chose to leave, goodbye.' Then came a second blow at the UN when it was suggested in Congress that our payments to the UN ought to be reduced. Nevertheless, President Reagan proceeded to treat the UN as though it really were a World Government, paid obeisance to its General Assembly. Result: The head that was wounded unto death, was quickly revived and as *U.S. News* asserted: 'The eyes of the world suddenly are focusing on big power politics at the United Nations.' But, let's backtrack and fill in some details:

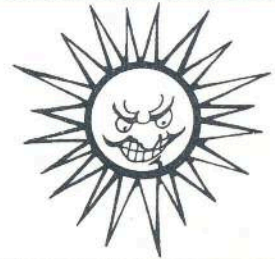
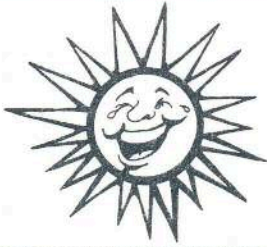
“With the shooting down of KAL Flight 007 and the murder of 269 people, 61 of whom were Americans including a United States Congressman, there came an immediate demand from the people that our government

retaliate. Among the more rational demands was that all grain sales, shipments or giveaways to the USSR be stopped. And immediately came the protests, allegedly from the farmers and the rural bankers. According to the controlled news media, the cancellation of grain shipments would 'hurt Americans more than the Russians'. But it seems that the protests actually came from the lobbyists for the Multinational Merchants of Grain, who had no desire to have their sales halted. Lenin said that 'Grain is the currency of currencies'. And there are said to be five multinational corporations that control the grain trade in this world, including all sales to the Soviet Union.

“Next rational demand of the people because of the murder of innocents: Impose strict economic sanctions on the Soviet Union; stop all trade and aid. But then came the refusal of the Megabankers and the Multinationals that trade with the Communist countries. The European Communist bloc countries owe the Big Banks \$80 billion. If they were to default on those loans, we are told that this could bring down the entire American banking system. So, say the Rockefeller interests: 'We have a vested

financial interest in preventing the collapse of international communism.' Whether we the people have any such vested interest is questionable; but the Trilateralists, the Megabankers and certain Multinational Corporations do have a vested interest in keeping Communism alive and well, even though this will always be at the expense of the American taxpayers. So, that's why President Reagan was careful to impose no economic sanctions on the Soviet Union. Instead, he retaliated by cancelling some Aeroflot flights. This, incidentally, caused some sympathy for the Soviets since that veteran Communist Andrei Gromyko could say he was afraid to attend the current UN General Assembly meeting because his airplane couldn't land on an American airfield.

“The third important demand of the people of America, because of the Soviet murder of innocents over the Sea of Japan, called for the expulsion of Soviet diplomats and all having any connection whatsoever with the Communist governments. This demand was, of course, soundly rejected by the Administration because any such action would interfere with the making of future deals of any kind with the



USSR. It might even jeopardise the continued existence of the Soviet government. And, as we said, 'We have a vested interest in preventing the collapse of international communism.'

"But here is the point we wish to stress: Unable to act as a President of the United States should act because of certain vested interests seeking to merge the USSR and the USA into a World Government, Reagan gave up and surrendered to the United Nations! First he appealed to the UN to act as judge and jury in the case of the shooting down of KAL Flight 007. In doing so he knew full well there would be no decision and all would be forgotten, given time. Next, and worst of all, Reagan then went personally before the UN General Assembly to ask that world body to help in arranging arms deals between the United States and the Soviet Union. To treat the UN General Assembly as though it were the arbiter of problems between two governments is to make it an arbiter, and therefore having the authority, *if not the power*, of a World Government! We feel that Reagan actually recognised the UN as a world government because of his opening words when he addressed the 38th session of the United Na-

tions General Assembly on September 26, 1983. We quote from his speech as published in *The New York Times* of September 27th:

"... I have come to discuss how we can keep faith with the dreams that created this organisation. The United Nations was founded in the aftermath of World War II to protect future generations from the scourge of war... What has happened to the dreams of the

UN's founders? What has happened to the spirit which created the UN? The answer is clear: *Governments got in the way of the dreams of the people.* Let's repeat that statement: 'Governments got in the way of the dreams of the people.' Does Ronald Reagan mean that governments should be gotten out of the way? That they should be eliminated, and all should submit to the higher authority of the United Nations?"

This surely seems to be the case and if so then the plans of the great conspiracy and its supreme pontiff as disclosed in the work *The Trail of The Serpent*, have almost come to fruition — BUT — the LORD will not be mocked.
